Minutes of Meeting (MOM) Proceedings:

- 1. The proceedings of the meeting commenced with a cordial welcome from Dr. Prasanna Shete, Convenor of the EOC.
- 2. Dr. Prasanna Shete presented and discussed the following agenda items.

2.1: Compliance of Barrier-Free Environment: The discussion encompassed various components of a barrier-free environment within the campus

- Observations:
- a) Confirmation of existence of ramps in all campus buildings.
- b) Lack of Braille keypad in the Lifts of SIMSR and KJSCE Bhaskaracharya Building.
- c) Limited Divyangjan-friendly washrooms across the campus, Suggested the need for washrooms on each floor for easy access by Divyang students.
- d) Absence of tactile flooring paths; not ample display boards, and signposts.





2.2: **Provisions for Inclusive Education:**

- a) Highlighted existing assistive technologies like screen readers, magnifiers, and voice recorders.
- b) Mentioned the availability of human assistance and various forms of support during examinations.
- c) Clarified the presence of these facilities in KJSCE and requested other colleges to share similar information.

2.3: Understanding Special Education Needs (SENs) of the PwD Students:

During the meeting, the topic of understanding Special Education Needs (SENs) of the PwD students highlighted the necessity for conducting a comprehensive need assessment of PwD students and an accessibility audit by external agency.

2.3: Planning of EOC Activities for Students, Faculty/Staff:

- a) Dr. Prasanna Shete shared the activities conducted in the past and briefed about EOC activities planned that includes workshops, meetings, and need assessment sessions.
- b) Outlined proposed upcoming activities along with their intended audiences and budgets.
- 3. Dr. Prasanna Shete requested the submission of specific details regarding PwD students, including the program-wise count, their year of study, type of disability, and their respective success rates spanning from 2020 to 2023 on urgent basis. This information was deemed crucial for immediate review and analysis for NAAC Accreditation Purpose.
